When the alarm sounds, please leave the building immediately and go directly to the meeting point. Arriving persons must report to the fire protection helper or first responder.



Pay attention to alarm signals.



Stay away from the accident scene. Pay attention to barriers.

Prohibitions throughout the premises



Smoking ban in all buildings. Smoking is only permitted in designated outdoor smoking areas.



Fire and open flames are prohibited (e.g. welding, flexing, gas burner). Only with permit.



Machinery, tools and materials may not be touched without permission.



Both photography and filming are forbidden on the premises (this also applies for mobile phones).

Please pay attention to the instructions for waste separation in our company.



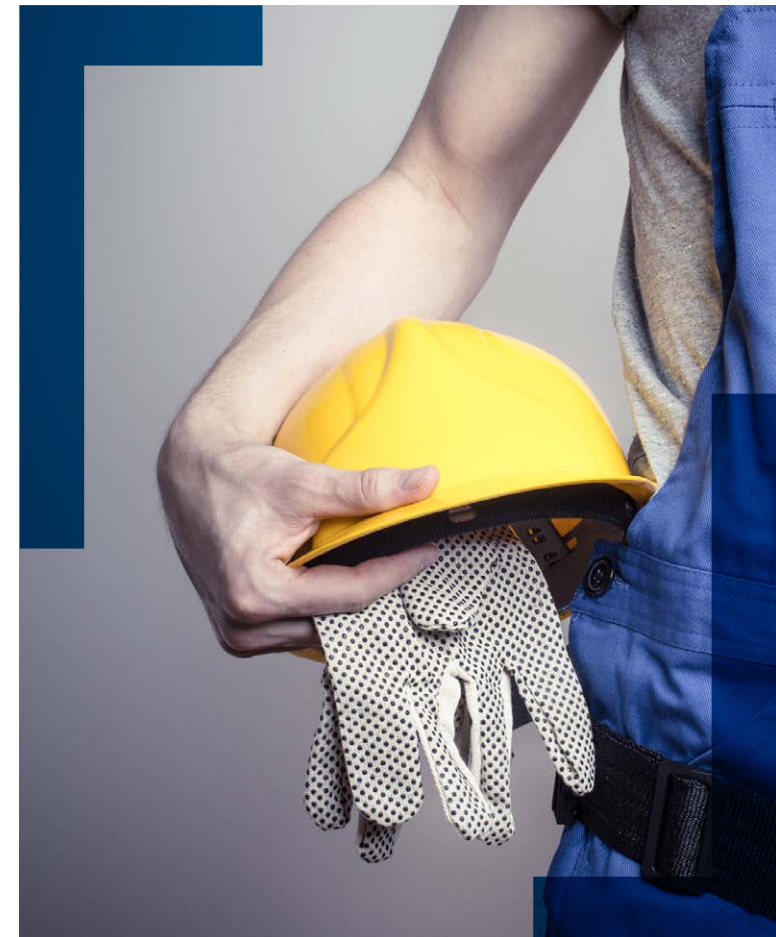

Safety rules

This visitor rules apply for all persons entering the premises of ift Rosenheim.

Safety is considered very important at ift Rosenheim. We commit ourselves to promote and safeguard secure working conditions. Furthermore, we will acquaint you with our most important safety rules, so that you can behave in a safe manner.

Please obey the following rules.

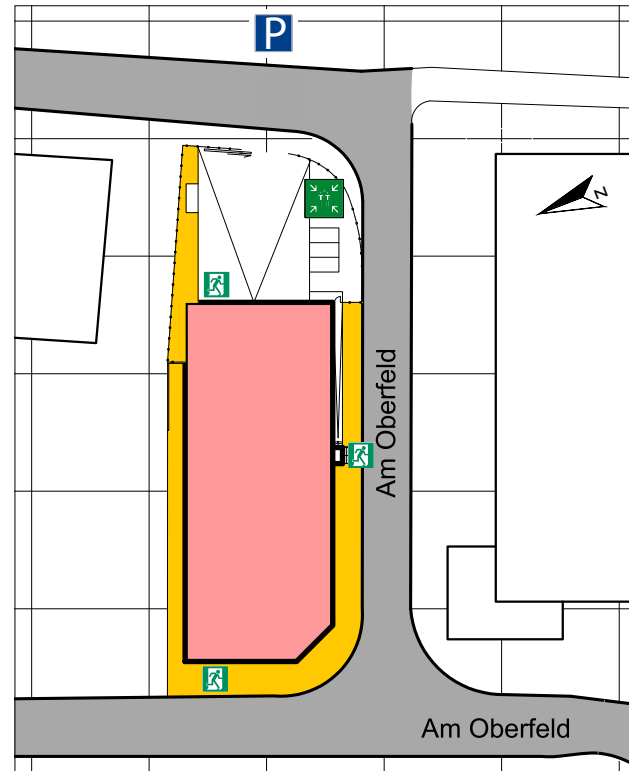
- Each external party is obliged to register at the reception (main building).
- At the reception, you acknowledge with your signature the receipt and the information of our safety rules and that you comply with them.
- The stay at our premises is basically permitted only with the escort of an ift-employee. Instructions are to be adhered to at all times.
- Keep sufficient safety distance from crane loads, test rigs, machinery and vehicles.

The instructions of the responsible operations manager, head of department, the visited ift-employee and/or security officer have to be followed.


Violations of the rules


If you break the mentioned rules, you are at your own risk when moving on the premises of ift Rosenheim and you are not insured by ift Rosenheim in case of damage. Furthermore, you have to reckon with the fact that there can be legal consequences and even an operating ban. The originator is liable for any damage caused by violation of the rules.

 In case of evacuation, the designated area next to the building serves as the assembly point.

The German Road Traffic Act (StVO) applies to the premises



The „Slow driving order“ applies to the entire premises. The maximum speed is up to 10 km/h.



No-parking zone: Fire brigade access, fire-extinguishing devices, traffic routes, emergency exits as well as areas designated by ground marking have to be kept clear.



Parking is only allowed on designated parking spaces.

Safety instructions at the premises



Wear hearing protection in designated areas.



Wear Goggles in designated areas.



Wear safety shoes (at least S1P) in designated areas. (Only as an exception, security overshoes are available in the laboratory.)



Smoking is permitted in designated outdoor smoking areas.



Do not reach into the in running test rigs/machinery. Keep a safety distance of 1 m to the machines.



Attention: Forklifts and forklift trucks will drive on the entire premises. So, please act with suitable consideration.
